## **TMS THERAPY EXCLUSION CRITERIA**

TMS Therapy may not be suitable for certain situations, as detailed below. The treatment coil of the TMS Therapy System generates powerful, pulsed magnetic fields that can have an impact on specific implanted devices or objects. The magnetic field strength diminishes rapidly with distance from the coil. Within 30 cm of the treatment coil's face, the peak magnetic field can exceed 5 Gauss, which is the recommended exclusion level for many electronic devices sensitive to static magnetic fields.

TMS Therapy is not recommended for patients who have conductive, ferromagnetic, or other magnetic-sensitive metals implanted in their head within 30 cm of the treatment coil.

Objects that can be affected by the magnetic field, such as jewelry or hair barrettes, must be removed before treatment to avoid potential harm. After these items are removed, TMS is no longer contraindicated for these patients.

Before commencing TMS treatment, please complete the provided form. If you have selected any of the options under the Contraindicated Section, TMS therapy is contraindicated for you, and thus, not a suitable treatment option.

In certain cases, patients may have questions about permanent tattoos, make-up, permanent mouth retainers, braces, or other types of metal in or around the head not listed as TMS Contraindications. The impact of TMS on such situations is not explicitly supported by significant research. While we are aware of specific contraindications (outlined in the Confirmed Contraindications Form), there is limited research on whether transcranial magnetic stimulation (TMS) could cause any adverse reaction, side effect, or complication for situations or circumstances not listed on our Contraindication Form.

By signing below, you confirm your understanding of the Confirmed Contraindications for TMS Therapy and agree that you do not possess any of the Confirmed Contraindications listed on the TMS Therapy Contraindications Form. Moreover, you acknowledge that while permanent tattoos, make-up, permanent retainers, braces, and other non-ferromagnetic materials in or around the head are not listed as contraindications, there remains a possibility of negative reactions, side effects, or adverse outcomes.
